


Survivor Story: From Dynamite to Detonator

"I remember the first time I saw her at the shelter," Bayleigh quietly said as she looked down at the floor. As the memory came back to her, she softly smiled, eyes still fixated on the ground.

Bayleigh tried to stop the flow of tears welling up in her eyes as she continued. "She was so sweet. Bashful, hiding in the corner, she was skiddish about coming toward me. Cocking her head to the right, she looked at me with these big, brown, curious eyes. She'd been hurt before. Not only could I see a few scars on her head, back, and both ears, but realized she must have been taunted, too. She hadn't had an easy life. She slowly crept my way. She wanted to be loved, but most of all she wanted to be able to trust again. Her little paw reached out of the cage. From that moment, not only our hands, but our hearts were connected. I never knew I was going to have so much in common with a dog."

Bayleigh had blindly gone to the animal shelter on her 10th date with Devin. She was literally blindfolded. They both agreed that if they liked each other enough to go on 10 dates, they'd make it official and become a couple. Devin knew that surprising her with a trip to the shelter and the purchase of a dog would definitely seal the deal. "I thought, 'this guy is too good to be true.' He's getting me a dog?! That was way better than flowers in my mind. Because of that, I named the dog Daisy. Devin had been nothing short of wonderful and caring to me in those first couple of months. I used to call him 'Dynamite Devin' when I spoke about him to my family and friends," Bayleigh said as she shook her head.



For the next couple of months, everything was normal. Devin was still the same wonderful and caring guy he was at the beginning. In fact, he was almost too caring. He started to worry about where she was from moment to moment. What time was she going to be home from work? How long would she be at the store? Where was she going with her friends and what friends would go with her? What was she talking about with her mother on the phone? Why was she talking to the neighbor and especially while wearing those short shorts? Bayleigh didn't notice any red flags, because to her, there were none. "I thought Devin was showing how protective he was. I thought he wanted to know everything because he worried about me. He wanted to know who I was with just in case something ever happened to me. And the shorts and the neighbor? Well, I thought about it and shrugged it off as jealousy. I kind of thought it was cute. I felt really loved and cared about."




Survivor Story: From Dynamite to Detonator

Eventually, if Bayleigh didn't have answers to Devin's questions, he responded with yelling, slamming his hands on a table, or punching a fist through a wall. Soon, Bayleigh became a target for his physical brutality. In addition to the hitting, he tried to strangle her. And then, he threatened to kill her. "Devin told me he could easily take my life. No one would care. He had alienated me so much from my family and friends, I started to really believe that no one would care," Bayleigh explained.

The abuse didn't stop here. "I came from work a few times and Daisy looked scared. I could see it in her eyes. She had that same timid look that she had in the cage at the shelter. Not only did Daisy have that look; I had it sometimes, too. I felt like we were both two frightened little beings, caged up and afraid," said Bayleigh. "I had wanted to leave so many times—for my sake—just pick up and run, you know? He'd

threatened Daisy before, but I had never seen him physically hurt her. If I did leave, I thought she might be alright and I could somehow get her back. But then I saw him—Devin grabbed Daisy by her scruff and threw her toward the wall. She whimpered, I cried, and I knew I had to get out. This was that final moment—the straw that broke the camel's back as they say," explained Bayleigh. "Devin went from dynamite to detonator. I don't even know how I did it, but I picked up the phone the next day at work and called you guys."

Granting WC&S a Great Future!

Get those shades ready — the future of Women's Center & Shelter is getting brighter!

With hearts full of gratitude, we're excited to share with you that we are the recipients of a competitive grant through the PCCD (Pennsylvania Commission on Crime and Delinquency) Victims of Crime Act (VOCA). What does this mean, you ask? It means our existing programs and services will expand and serve survivors of intimate partner violence in an even more robust way.

You want specific details? Here you go:

• This grant supports the **expansion of our outreach services in local communities.** WC&S will now facilitate up to 10 weekly community-based support groups for at least 100 new, underserved survivors of IPV per year. We are thankful that victims of intimate partner violence who encounter barriers to services due to their location will be able to receive the help they need.

- This grant also expands a successful program designed to meet the immediate emotional, psychological, physical health, and safety needs of victims of intimate partner violence who are using our services. Initially started three years ago through a United Way United for Women grant, the program has been so successful that we have received renewal funding from the United Way for current programming AND are expanding by adding two full-time staff through VOCA to serve additional Legal and Empowerment Center clients.
- We are also very excited that this VOCA grant allows our
 Civil Law Project to hire a new attorney with a specialization
 in immigration and family law to work with victims of IPV
 who are refugees, immigrants, and limited-English speakers.

We are thrilled for the support to offer these expanded services!
