#### <u>Justice Department Announces Total Distribution of Over \$4 Billion to Victims of</u> <u>Madoff Ponzi Scheme</u>

"The Criminal Division is proud to continue providing compensation to victims through the largest remission process the Department has overseen," said Assistant Attorney General Kenneth A. Polite, Jr. of the Justice Department's Criminal Division. "The

billions distributed worldwide is a testament to the department's sustained efforts to ensure justice for the victims of Bernard Madoff's massive fraud." #### U.S. Attorney Designates Two Assistant U.S. Attorneys to Coordinate the Office's Environmental Justice Efforts

United States Attorney Cindy Chung has named two Assistant U.S. Attorneys to oversee the office's Environmental Justice work. Criminal Division AUSA Nicole Vasquez-Schmitt and Civil AUSA Jacqueline Brown are serving as the office's Environmental Justice

Coordinators to enhance and advance the office's Environmental Justice efforts. Environmental Justice is the fair treatment and meaningful involvement of all people regardless of race, color, national origins, or income with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies. "These designations will serve to enhance our longstanding commitment to vigorously enforce environmental laws, with a particular emphasis on minority and lower-income communities," said U.S. Attorney Chung. "We will continue to protect western Pennsylvania's vast natural resources while holding those who violate federal environmental laws accountable." The Office

#### Western District of Pennsylvania Takes Part in Department's Wide-Ranging Efforts to Protect Older Adults

"My office is committed to ensuring that the elderly and other vulnerable citizens avoid falling victim to financial exploitation," said U.S Attorney Cindy K. Chung. "In addition to prosecution, prevention is an important component of our work. #### Jeannette Man Pleads Guilty in IRS Impersonation Fraud Scheme

In connection with the guilty plea, the court was advised that from in or around March 2016 to in or around August 2017, Ronnell Taylor, Jr. participated in an IRS impersonation fraud conspiracy. The IRS impersonation fraud scheme involved call centers located in India that would use phone numbers to make their calls appear to originate in the United States. The calls would provide recorded information to individuals in the United States and fraudulently claim that the call was from the IRS concerning the individual's failure to pay taxes. The call would provide a U.S.-based telephone number for the individual to call in order to resolve the matter. Calls to these U.S.-based telephone numbers would be automatically forwarded to call centers in India, and those who answered would tell callers that they owed money to the IRS and demand immediate payment via gift card or other means. <u>Read more</u>

#### Pittsburgh Man Indicted on Sex Trafficking and Child Sexual Exploitation Charges

According to the seven-count Indictment, from in and around June 2019 to in and around April 2022, Jefferson attempted to and did by force, threats of force, fraud or coercion, cause four different adult females, who are known to the grand jury, to engage in commercial sex acts. Additionally, the Indictment alleges that from in and around February 2021 to in and around May 2022, Jefferson used the internet and cell phone to promote, manage, establish, carry on, and facilitate the promotion, management, establishment, and carrying on of a business involving prostitution, in violation of state and federal law. The Indictment also alleges that on or about May 29, 2017, Jefferson produced a visual depiction of a minor engaging in sexually explicit conduct. Lastly, the Indictment alleges that, on or about May 18, 2022, Jefferson possessed material depicting the sexual exploitation of minors who were under the age of 12. <u>Read more</u>

#### Turtle Creek Man Sentenced to 5 Years for Using Stolen Credit Cards at Area Retail Stores

According to information presented to the court, the evidence at trial established that in the summer of 2017, the Pittsburgh Bureau of Police and the Allegheny County Police investigated a series of vehicles that had been broken into while parked at various entertainment venues, including the Boyce Wave Pool, the Pittsburgh Zoo and similar venues. The victims reported the theft of their credit cards and means of identification and the use of the credit cards, typically on the same day as the break-ins. Investigators secured video of Davis using and attempting to use some of the stolen credit cards at various retail establishments. The later investigation revealed that an individual named Terry Porterfield broke into the vehicles and then transferred the credit cards to Davis and others, who then used the credit cards to purchase primarily gift cards and electronic equipment. <u>Read more</u>

#### <u>Freedom, PA Man Charged with Attempted Sex Trafficking of a Child and Receiving Images of a Minor</u> <u>Engaging Sexually Explicit Conduct</u>

According to the Indictment, on or about May 22, 2021, Kriss did knowingly receive a visual depiction of a minor using any means and facility of interstate and foreign commerce, namely, the Internet and a

cellular telephone, the production of which visual depiction involved the use of a minor engaging in sexually explicit conduct, and that depicted a minor engaging in sexually explicit conduct. Further, Kriss knowingly attempted to solicit the child to engage in a commercial sex act. Specifically, the indictment alleges Kriss was engaged in a text message conversation with the minor and asked the child to send him sexually explicit images of herself. Kriss received the images and also solicited the child to have sex with him for money. Kriss later picked up the child in a church parking lot before taking her to a motel room and sexually assaulting her. <u>Read more</u>

#### Pittsburgh Man Pleads Guilty to Child Sexual Exploitation Charges

In connection with the guilty plea, the court was advised that from Feb. 25, 2021, until July 26, 2021, McNutt used the Internet and a cellular telephone to knowingly attempt to persuade, induce, entice, and coerce an individual who had not attained the age of 18 years to engage in sexual activity. Specifically, McNutt engaged online with law enforcement acting in an undercover capacity and purporting to be a parent and child. McNutt expressed interested in meeting the child for sexual conduct and sent the purported minor's parent money to enable the parent and child to travel to Pittsburgh to meet McNutt for sexual conduct. McNutt planned to meet the purported minor and parent at a hotel in Pittsburgh that he booked. On July 26, 2021, law enforcement intercepted McNutt when he arrived at the Pittsburgh-area hotel to meet the minor. <u>Read more</u>

#### <u>Justice Department Announces \$21.72 Million to Reduce Sexual and Domestic Violence on Campus,</u> <u>Support Children and Youth and Engage Men and Boys as Allies</u>

"Studies show that approximately one in five women surveyed have been victimized by sexual assault while in college," said Associate Attorney General Vanita Gupta. "We need to support college campuses with the resources to create a campus culture that is not tolerant of sexual assault or dating violence. These grants will help colleges and universities develop prevention policies, offer survivor-centered services, and train campus police to meet the needs of their students. These grants also provide critical intervention services to children and young adults, in addition to engaging them to be leaders in combatting violence." <u>Read more</u>

#### DocuSAFE: Documentation and Evidence Collection App

<u>DocuSAFE</u> is a free app that helps survivors collect, store, and share evidence of abuse, such as domestic violence, sexual assault, stalking, online harassment, and dating violence. Survivors can document abuse by logging individual incidents, including any photos, screenshots, or video documentation of threatening messages, harassing social media posts, unwanted repeat calls, or online impersonation, among other abusive behaviors.
