

DIRECT SERVICE ADVOCATE (part-time)

About the agency. Women's Center & Shelter of Greater Pittsburgh (WC&S) is a comprehensive domestic violence program annually serving approximately 7,500 individuals impacted by domestic violence & facilitating an intervention program to over 300 people who use abuse. We are advocates, grounded in fostering a community of safety, healing, and empowerment for anyone affected by domestic violence. Our mission is to strengthen our ability to meet the individual and evolving needs of those affected by domestic violence by investing in the growth of our people, deepening community engagement, and amplifying the voices of all survivors. All staff learn about and support the organization's mission, vision, and values of Safety, Uplifting Others, Compassion, Courage, Equity, Survivor-Centered Advocacy, and Stewardship (SUCCESS). In addition, the principles of Sanctuary (a model for providing trauma-informed care) and continuous improvement infuse all aspects of the organization.

About the role. As a Direct Service Advocate, you will provide direct service advocacy, safety planning, emotional support, psychoeducation, case management, and information & referrals to clients of the WC&S Emergency Shelter, 24-Hour Hotline, and Text/Chat. You will have the ability to effectively work with adults and children who have experienced trauma, handle crises, manage multiple client cases and needs, and be a resourceful problem solver with strong attention to client safety, confidentiality, and wellbeing. Due to the sensitive nature of our work, it is important that you understand abusive family dynamics, including intimate partner violence (IPV), cycle of abuse, power and control dynamics, and child abuse and neglect. The successful candidate is sensitive to trauma and cultural diversity issues and is passionate about serving those experiencing IPV. This part-time role is based out of the WC&S Residential Program, which is housed in the main WC&S facility.

This role provides you with the opportunity to showcase your active listening, communication, and crisis management skills, and the ability to contribute to the organization's mission in a variety of ways. If you are comfortable building rapport, thinking outside the box, and working with a team to meet ever-changing needs, we are eager to hear from you. WC&S will offer you an environment that provides endless opportunities to advance your knowledge and skills.

Here's what you will do:

- Maintain building security at all times and assures confidentiality of clients
- Provide intake interviews with residents to identify individual needs
- Work with residents on meeting basic daily needs
- Provide information to residents regarding safety, housing, health care, and financial options
- Provide crisis counseling, safety planning, and information and referrals to Hotline callers and to users of Chat/Text Program
- Assist with training new staff, volunteers, and interns for Hotline work
- Provides support to coworkers, volunteers, and interns in Shelter
- This part-time position requires being available weekly on Tuesday, Wednesday, and Thursday evenings, from 4:00p to 12:00a (midnight)
- Perform other duties as assigned by supervisor



Here's what we are looking for:

- High school diploma/GED required
- At least one (1) year of experience working in direct service in a human service agency
- Effective verbal, written, and interpersonal communication skills
- A demonstration of the understanding of abusive family dynamics, including intimate partner violence, cycle of abuse, power and control dynamics, cultural diversity issues and child abuse and neglect
- Ability to establish healthy boundaries, trust, respect, and rapport with others
- Ability to understand and adhere to strict confidentiality and safety procedures
- Strong command of general technology, including, but not limited to, Microsoft Office Suite is required; familiarity and understanding of information technology, including Salesforce and Teams strongly preferred
- Desire to work in an organization committed to diversity, equity, and inclusion as part of its values
- Act 33/34 and FBI Clearances required

Physical demands. (*Note:* The physical demands listed below may be representative of those required on the job. Reasonable accommodations may be made to enable qualified individuals with disabilities to perform essential duties and responsibilities.)

- Ability to stand, walk, bend, and ascend/descend stairs (if elevator not an option)
- Ability to move, carry, and/or lift items/packages up to 25 lbs. at times, including transporting necessary equipment and materials (e.g., laptop, phone, documents, etc.)
- Prolonged periods of sitting at a desk and working on a computer, with breaks as needed
- Ability to use standard office equipment and technology (e.g., computer, keyboard, mouse, printer, etc.)
- Ability to access and physically navigate various departments and organizational facilities, as well as relevant offsite locations (if applicable)

Typical Hourly Rate: \$16.47/hour, plus eligible for +\$1.00-\$4.00/hour shift premium differential for weekend, evening, and overnight hours

About the benefits.
